

# What's In It For Me?

much in police work that is super secret.

The upside of having trained citizens to assist the police is great. A second set of eyes on a police problem can be very helpful in solving and preventing crime.

In these days, with terrorism and other complex crimes providing challenges to the police and society, an extra set of *trained* eyes can be a very important and effective asset to the police. Many cases that I have worked in my 30 years in law enforcement have been solved by citizen witnesses who have made observations or overheard a conversation and came forward and reported it. Can you imagine how much more common this would be if these eyes and ears received the same type of training that Citizen's Police Academy programs provide?

The reason to join the Illinois Citizen's Police Academy Association is to take this program one step further.
