Attendees will also hear from two "surprise" guest speakers that are each available to conduct a class for you and your CPA students or alumni association members at little or no cost!

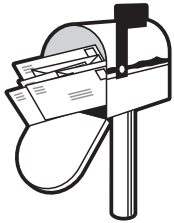

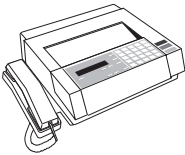
